<b>What is the overall <a href="#">deductible</a>?</b>	In- <a href="#">Network</a> / <a href="#">Participating Provider</a> : \$3,000 Individual / \$6,000 Family; <a href="#">Out-of-Network Provider</a> : \$9,000 Individual / \$18,000 Family	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of the <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. <a href="#">Preventive care</a> and services indicated in chart beginning on page 2	This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount.
