What is the overall deductible ?	Plan Provider : \$500 Individual / \$1,000 Family. PAR Provider : \$1,500 Individual / \$3,000 Family. Non-PAR Provider : \$4,500 Individual / \$9,000 Family.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes, Preventive care , and services, indicated in the chart starting on page 2.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes, \$200 per person for PAR Provider : non-preferred and specialty prescription drug expenses. There are no other specific deductibles . Will you pay less if you use a network provider ?	Yes.
