What is the overall <a href="#">deductible</a> ?	<a href="#">KP Select Provider</a> : \$5,000 Individual / \$10,000 Family <a href="#">PPO Provider</a> : \$6,500 Individual / \$13,000 Family <a href="#">Non-PAR Provider</a> : \$8,500 Individual / \$17,000 Family	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes, <a href="#">Preventive care</a> , and services, indicated in the chart starting on page 2.
